- **Judging commences 9.30 am Wednesday - Saturday.**
- Entry for exhibitors will be via the Main Gate between 7.30am to 8:30am Wed-Sat and under no circumstances are exhibitors to arrive on Tuesday to claim benches. Exhibitors will be notified daily by Committee on exit times. Cars **ARE NOT** permitted onto the showground before 5:00pm each day or **as directed by the Society**. Limited pre-paid parking will be available at a cost of **\$20.00** per day. **REGULATIONS PERTAINING TO THE EXHIBITION OF DOGS AND CONDITIONS OF ENTRY:**

To be held under the regulations of the Tasmanian Canine Association Inc., a copy of which may be inspected at the office of the Society. The General Regulations of the Society shall form part of the conditions of entry.

**RETURN OF EXHIBITS FOR GENERAL SPECIALS:**

Exhibitors whose dogs are required to be returned for General Specials must obtain a new exhibit number and new exhibitor's pass. Exhibitors' passes and exhibit numbers are available from the Kennel Complex show office and it is the responsibility of the exhibitor to collect these prior to leaving the grounds. Exhibitors without the appropriate passes will be charged general admission.

**AMISH CHALLENGE**

The Amish Challenge is a sweepstakes event held at selected shows throughout Australia. To be eligible to participate in the competition the dog must be owned and handled by its breeder.

Three cash prizes are on offered by "Cordmaker" Puli:

The winner will receive a rosette with prize money of \$1,000.00

First and Second "Award Merit" will received a rosette with prize money of \$500.00 each.

**The Rules to enter this Competition are**

1. The competing dog must be breeder/owner/handled
2. If the dog is co-owned it must be the breeder who handles the dog and such breeder must also be one of the registered owners.
3. The breeder is the person/s whose is name is attached to the prefix at the time the litter was officially registered with the respective Canine Controlling Body. If the prefix is later transferred to other parties, it is the date of registration of the litter that determines the dog's eligibility for the competition. If the prefix is in co-ownership, multiple dogs belonging to that prefix maybe but, each must be owner/breeder/handled.
4. Any KENNEL PREFIX that has won this event, anywhere in Australia, is **NOT** permitted to enter the event again. Note:- it is the PREFIX that is excluded from further competition. A current list of past winners is available from Sue Huebner.
5. A standard entry form should be completed for this completion, including details of the Breeder/s, Owner/s and the handler of the dog.
