SHOW REGULATIONS

GOATS MUST NOT LEAVE UNTIL AFTER JUDGING AT THE SECTION COUNCILLOR'S DISCRETION.

Run under the auspices of the Dairy Goat Society of Australia-Tasmanian Branch Show Rules.

- **1.** Exhibitors must be members of the Dairy Goat Society of Australia. All goats except kids if under 12 months of age, must be registered with the DGSA.
- **2.** Goats are ineligible to enter if they are IR registered, or IR pending registration.

In addition to any special regulations herein all Exhibitors in this section are subject to the General Regulations for Competitors and Exhibitors of the Royal Agricultural Society of Tasmania, copies of which are available on request from the Society.

- 9. In handling animals, there is a risk of suffering injury including injuries caused by the animals.
- 10. I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation

- of the Event and/or in using the Suppliers' facilities.
- 11. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event and/or in using the Suppliers' facilities.
- 12. I use the Suppliers' facilities, including for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me, both obvious and inherent.
